

## **CBS44 WEVV “NCAA Tournament Tickets” Official Rules**

*Void where prohibited or restricted by law. Odds of winning the contest are dependent upon the number of entries received.*

**Eligibility:** Entrants must reside in the Evansville DMA (as defined by Nielsen Media Research) and maintain a mailing address in Indiana, Kentucky or Illinois, and be at least 18 years of age on the day the contest begins.
